The 40th Annual Festival of the Arts is a 2-day outdoor event held in Cook Park located in historic downtown Libertyville, Illinois. With an emphasis on the visual arts, this family friendly event is presented by the David Adler Music and Arts Center and the Green Oaks, Libertyville, Mundelein, Vernon Hills Chamber of Commerce. The festival will feature up to 75 artists, as well as live music, beer garden, children's activities, and food vendors.

Exhibitor Rules and Regulations

1. The festival provides the 10 x 10' booth space only. Exhibitors are responsible for providing their own display materials, tents, tables, chairs, weights, etc. Tent stakes or any other material that penetrates the ground are not allowed in Cook Park.
2. All exhibitors are responsible, by law, to pay all applicable city, state and federal taxes for work sold.
3. All work exhibited must be original handwork, not the work of mass production studios. All work presented must be finished. Two-dimensional art should be framed or equivalent. All artwork on display must be for sale.
4. The Adler Center reserves the right to refuse exhibition of work not consistent with submitted examples of artistic work.
5. Exhibiting artists accept full responsibility for the care and safety of their work. The David Adler Music and Arts Center, GLMV Chamber of Commerce and the Village of Libertyville assume no responsibility or liability for damage, theft, vandalism or lost or stolen property.
6. Artists must be present with their work for the duration of the Festival.
7. The Festival of the Arts Jury will judge entries based on originality of artwork and quality of the booth display. Judging will take place on Saturday.
8. The Festival is a rain or shine event.

AWARDS

The Festival of the Arts Jury will judge entries based on originality of artwork and quality of the booth display. Judging will take place on Saturday for Best of Show (\$150 prize) and Best of Category (\$50 prize).

AMENITIES

- Two (2) tickets redeemable for coffee at the festival information booth
- Two (2) tickets redeemable for bottled water at the festival information booth
- Food Vendors on Church Street adjacent to Cook Park
- Booth sitters are available during event hours via text request

LOAD IN/LOAD OUT

Load in will begin at 6:30am on Saturday, August 1st. Artists can load-in only during the designated times and must check-in at the Adler Center check in stations to receive Exhibitor packet. You must unpack then move your vehicle before you start set-up. Load out will begin at 5pm on Sunday, August 2nd. Further directions will be distributed closer to event date.

PARKING

Designated parking will be provided for Festival Exhibitors.

SALES TAX

Artists are responsible for collecting and reporting Sales Tax. A Sales Tax form is provided at check-in. The current Village of Libertyville sales tax rate is 7%.
